The vaccine obligation has begun for everybody over 50 years of age residing in Italy, both Italians and foreigners, with the exception of those who are exempted for health reasons. For those recovered from Covid, the obligation starts six months from the date of recovery. The obligation is valid until 15 June and also applies to all those who will turn 50 by that date. Furthermore, starting from tomorrow, the time for administering the booster dose becomes shorter, making it possible to inoculate it after 4 months.
